



#### LOCAL EXAM

Chest - B/L Air entry equal, no added sounds

CVS - Precordial bulge +, Hyperdynamic precordium, S1 - N, S2 - split not appreciated, Pansystolic murmur 4/6 at LLSB

P/A - No hepatomegaly (On diuretics)

Echo - SS, LC. NRGA, L arch. Normal systemic, pulmonary veins.

TV overriding the IVS almost 40-50% with Type A Straddling (Attached to summit of IVS).

No TR/MR. No PDA/COA.

Large inlet VSD restricted by STL tissue (Effective size 4.5-5mm), L-R shunt with gradient 56mmHg.

Dilated LA/LV, RV borderline. Normal biventricular function.

Mild PR Early DG = 21mmhg (Fragmented signal), MPA not very dilated in comparison to Aorta, supporting the notion of hyperkinetic PAH.

Case discussed - Plan: 1.5V Repair with Back up of PA Banding (Palliation) if straddling doesn't allow VSD closure intraoperatively.


